Research Brief

The second issue of Research/Policy Brief, *Remittance Received by Households Varies by Migrant's Destination* by Prem Bhandari will be at your hand soon.

Abstract

This research brief explores whether a household's receipt of remittances as well as the amount of remittances received varies with place or country of work of the migrant member of the family. Using household level data from Chitwan Valley in Nepal, the study shows that the net of controls, both the receipt as well as the amount of remittances received by a household depends on the place of work of the migrant. Remittances from countries with high earning potentials (such as the Middle East, East or Southeast Asia, United States, Australia and Europe) were significantly higher when compared to migrants from other destinations like Nepal and India.

On October 23, 2017, Dr. Upendra Sainju, NAPA Adviser and Ambika Tiwari, Treasurer shared information about NAPA at the Specialty Group Meeting, a group of scientists and students of Nepali origin at the Tri-society meetings [ASA-CSSA-SSSA Meeting, Oct 22-25, 2017; https://www.aaaspolicyfellowships.org/events/asa-cssa-sssa-2017-annual-meeting], Tampa, Florida. They provided a review and update of NAPA (www.napaamericas.org) activities and upcoming NA-PA Conference to be held on May 25-26, 2018 (Memorial Day weekend) in Oklahoma City, OK. A total of 38 participants were present in the meeting.





Talk Session Summary

Poverty Alleviation and Prosperity: Strategy, Policies, and Programs
Dr. Y.B. Thapa (NAPA Advisor)

Vice-Chair, Poverty Alleviation Fund, and Adjunct Professor, Agriculture and Forestry University, Nepal

NAPA's seventh talk session was held on November 4, 2017 by Dr. Y.B. Thapa (NAPA Advisor). In this session, Dr. Thapa talked about support to the economically disadvantaged communities towards entrepreneurship, skilled employment and transformations using the framework of multi-dimensional poverty indices. He

highlighted poverty rates/trends in relation to the occupational patterns and labour market; economic growth rates by industry in relation to product market and trade. He further discussed investment patterns by agency and industry in relation to the fiscal/monetary policy, and financial markets. He further discussed about poverty reduction approaches in Nepal and her neighbors with a focus on the Multidimensional Poverty Index (MPI)-related Sustainable Development Goals (SDGs) implementation mechanism, and institutional capital. He also discussed the linkages among poverty, employment, social protection, and investment with particular emphasis on the role of agriculture, food, and nutrition activities, and other basic services. His detailed and interesting talk session was well received by a large number of NAPA members.

KEYNOTE ADDRESS

Dr. Drona P. Rasali, Director, Population Health Surveillance and Epidemiology, British Columbia Center for Disease Control, Canada, and Chair of NAPA Book Publication Committee, was recently invited as a keynote speaker at the International Buffalo Symposium held at Agriculture and Forestry University, Nepal. His talk was entitled Buffalo Production for Food Security in Nepal. He discussed various aspects of buffalo





CALL FOR STUDENTS' WRITING CONTEST

NAPA-Student Coordination Committee is pleased to announce 2018 college and university students' essay writing contest. A full time student enrolled in a college including community or vocational college, and/or university around the globe pursuing a degree in agricultural or related fields¹ is eligible to participate.

Essay Topic: Global Food Security through Agricultural Transformation

General Guidelines:

- The essay should be written in English language. The essay must be author's own work and should attest it by inserting a statement² followed by his/her name.
- The essay should follow a standard academic essay structure and format including an introduction, body of supporting arguments and a conclusion.
- The essay can be developed based on student's own experience, online research, and literature review.
- The essay will be disqualified for the competition if any evidence of plagiarism is established. The committee is strict against plagiarism and advise each candidate to avoid engaging in such plagiarism.
- The essay should not exceed 3,000 words, excluding footnotes, tables, figures and references, and should be formatted double-spaced. The essay should have author's name, affiliated university, degree program, mailing address, and email with a proof of student's status e.g. ID card or unofficial transcript.
- ◆ A pdf copy of the essay can be submitted electronically via email at <u>NAPA2072@gmail.com</u>. The deadline for submission is March 12, 2018 (please note it is extended from February 28, 2018).
- Only one essay can be submitted per contestant.
- The results will be announced by the first week of April.

Regular or General (\$50.00 for two years): Individuals who hold at least an undergraduate or bachelors or equivalent degree in agriculture or allied areas shall meet the requirements of this category.

Student (\$25.00 for two years): Current students of agricultural and allied areas of studies who are at good standing student's status.

Life Membership (\$500.00 One time): Individuals having met regular/general member's category and pays defined dues at a time.

Joint/Family/Spouse Membership (\$15.00 for two years): Spouse of a member of any of the five categories (regular/general, student, life, honorary, and associate), who is not eligible for other categories of membership. Family member shall not have a voting right.

Associate Membership (\$50.00 for two years, \$500 for Associate Life mem-

ber): Interested individuals who do not qualify for membership types above. Associate member shall not have a voting right and shall not be eligible Executive Committee member. An Associate member may qualify for Associate Life member with the necessary payment.
